### **POOL OPENING**

The swimming pool will open at variable times beginning June 1st through Labor Day 2022.

Your account must be current to access the pool.

### **KEYCARD ACTIVATION**

Keycards will not be activated until all the 2022 Pool Forms have been completed and submitted. The Pool Forms are available online at:

[www.sablecove.org](http://www.sablecove.org)

Completed forms (You must complete all forms) should be dropped in the HOA drop box located on the corner of the building by the mailboxes. We try to activate cards within 24-48 hours of receiving the completed forms and verifying eligibility. Do not expect your card to be activated the same day.

### **KEYCARD DEACTIVATION**

**IF YOU FAIL TO FOLLOW THE RULES, YOUR CARD WILL BE DEACTIVATED!**

Keycards will have pool access turned off should the unit become delinquent or if any violation of the published rules occurs. This includes allowing anyone access to the pool who does not have a working keycard.

**IF A KEYCARD DOES NOT WORK, CALL MANAGEMENT at 303-337-5811** during regular business hours. Use of the Maintenance Emergency Pager to report keycard problems will result in the addition of a \$25.00 charge to the reactivation of the card.

Lost keycards will be deactivated prior to the issuance of a new keycard. Replacement keycards cost \$25.00.

## 2022 Pool Rules

1. Due to a nationwide chlorine shortage the pool is open only when the cover is open. There will be no set days or hours in 2022. The pool chemistry must be within safe ranges for the safety of all users.
2. The pool is reserved for the use of Sable Cove residents ONLY
3. **Please keep the gates to the pool closed at all times.** Do not let anyone in; all residents should have their own pool keycards. Failure to follow this rule WILL result in the deactivation of your keycard.
4. ONE Guest per pool card will be allowed in 2022.
5. If the county health department invokes restrictions to insure distancing requirements (6 ft), residents of 17 years of age or younger must be supervised at all times by an adult (18 years or older).
6. No running, jumping, diving, fighting, or dangerous conduct is allowed in or around the pool area. Any excessive noise is forbidden in or around the pool area.
7. Residents are required to be properly attired at all times going to and from and in and around the pool area. No flashing of inappropriate body parts or Aurora Police Department will be contacted immediately.
8. Diapers, whether cloth or disposable, must be covered with rubber pants.
9. Persons having infectious diseases, open sores, bandages, cuts or recent vaccinations are not permitted within the pool area.
10. All refreshments must be served in unbreakable containers. GLASS OBJECTS ARE NOT PERMITTED IN THE POOL AREA AT ANY TIME.
11. NO ALCOHOL may be consumed in or around the pool area.
12. Pets are not allowed in the swimming pool area.
13. NO LIFEGUARD WILL BE ON DUTY.
14. Everyone must obey all directives from Sable Cove agents including Board Members, pool staff, and management. Failure to do so is not acceptable and may result in pool closure, pool card deactivation and/or fines.
15. Management assumes no responsibility for accident or injury and is not responsible for articles that are lost, damaged or stolen. POOL IS USED AT YOUR OWN RISK.
16. Residents and their guests must abide by all rules posted in or around the pool area and should observe any warning signs placed in or around the pool area.
17. No pool furniture will be provided in 2022.
18. Throwing rocks in pool area or into the pool will not be tolerated. Pool card will be deactivated for a minimum of 30 days and fines may be assessed
19. Every homeowner will use appropriate language around pool area. Foul language is not acceptable and may result in pool closure, pool card deactivation and/or fines.
20. NO barbecues are allowed inside the pool area.

**Please keep the gates to the pool closed at all times. Do not let anyone in. Each resident must have his own keycard and must use it to enter the pool.**
